AN ORDINANCE REPEALING ORDINANCE NO. 2016-0502 REGARDING THE REGULATION OF DOGS AND CATS

The Board of Supervisors of the Township of Turtle Lake ordains:

Section 1. Findings. The Town Board hereby finds as follows:

- (a) On May 2, 2016, the Town Board adopted Ordinance No. 2016-0502, "An Ordinance Regulating Dogs and Cats within Turtle Lake Township" (the "Animal Ordinance"); and
- (b) The Town Board has since determined that the continued administration and enforcement of the Animal Ordinance is not in the best interests of the Township.

Section 2. Repeal. The Town Board hereby repeals the Animal Ordinance.

Section 3. <u>Effective Date</u>. This ordinance, and the repeal of the Animal Ordinance, is effective on the first day of publication after adoption.
